# Resource activity: Site specific petroleum activity

It is advised that Senex Assets Pty Ltd, ACN 160 649 338, a wholly owned subsidiary of Senex Energy Pty Ltd (Senex), has lodged an application for an environmental authority (EA) in accordance with the requirements of the *Environmental Protection Act 1994*.

The application relates to the transition from exploration to production activities over the area of Authority to Prospect (ATP) 2059 about 15 km south-west of Wandoan, Queensland. ATP 2059 is located in the headwaters of the Fitzroy River Basin, which is part of a Great Barrier Reef catchment area and may engage s41AA of the Environmental Protection Regulation 2019.
